Archbold Mitchell operates in Camilla, Georgia as a critical access hospital with 25 acute care beds. Archbold Living Camilla, and Archbold Living Pelham (located in Camilla, Georgia and Pelham, Georgia, respectively) operate as long-term care facilities with combined 156 nursing home beds. These facilities serve Mitchell County, and 57% of the patients were Medicare/Medicaid. In FY 2024, approximately \$4.9 million of indigent care was provided to the community. In addition, Archbold's Mitchell County facilities provided an estimated \$5.6 million in additional uncompensated care. These facilities serve Grady County, and 55% of the patients were Medicare/Medicaid. In FY 2024, Archbold Grady provided approximately \$6.2 million in indigent care. Should any such penalties and interest be incurred, they would be recognized as operating expenses.

Based on the results of management's evaluation, no liability is recognized in the accompanying consolidated balance sheets for unrecognized income tax positions. Further, no interest or penalties have been accrued or charged to expense as of September 30, 2024 and 2023 or for the years then ended. The Medical Center's tax returns are subject to returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.
