During new employee orientation, new hires are introduced to resources available within the health system to communicate with patients with Limited English Proficiency or who have vision, speech, or hearing impairments. The hospital utilizes a Healthstream online educational course, "SQ Acute: Care Delivery, Culturally Competent," for additional training, and this course is assigned to new hires upon employment. All employees are required to complete this course on an annual basis along with attend in-person classes that include education on cultural competency and CLAS for our patients.

What is the most urgent tool or resource you need in order to increase your ability to provide Culturally and Linguistically Appropriate Services (CLAS) to your patients?

Directional signage is currently available only in English and Braille; it would be helpful to add Spanish for patients and visitors and have maps of the campus in Spanish. Additionally, adding functionality of on-line interpreter services to bedside charting within the electronic health record would be much more user friendly to patients and more time efficient for staff.
